**NOMINATION FORM FOR ELECTIONS 2021**

Your Coram Civic Association Board of Directors consists of nine individuals from the Coram community who are elected volunteers. These nine directors consist of seven corporate officers and two non-officers. Your Board of Directors is responsible for planning the objectives, goals, and strategies for your Coram Civic based on the expressed needs and desires of our membership. All decisions are made on a majority basis through consensus by your Board with each Director having *one equal vote*.

In order to maintain a vibrant, proactive civic as well as an organization reflective of our always-evolving community culture and generational shifting, the seven corporate Officer/Director positions serve a two-year term, and the two non-officer Director positions serve a one-year term. Therefore, normally, the procedure is to have four of the Officer/Director positions voted on during even years along with the two annual non-officer Director positions, followed by the remaining three Officer/Director positions and two annual non-officer Director positions during the odd years. Because of the pandemic last year, we were unable to hold our normal elections in 2020, so this year the Term Expiration dates will be as shown below. This procedure allows us to get back on the odd/even officer election schedule in 2022 and provides for all members of our Coram Community Civic to have the opportunity to run for a leadership role for the Coram Civic...and new ideas, new energies, and new approaches are always welcome and needed for the overall health of your organization and your Coram Community!

**REQUIREMENTS: Nominees must be a current (dues current) active members of the Coram Civic Association. If nominating someone other than yourself, please confirm that person's interest first. All nominees will be contacted to prior to balloting to assure their continued interest in serving.**
